NOTICE TO APPLICANT:

All accounts are due and payable upon your receipt of a billing. All accounts due that are not received by the 25th of the month will be considered overdue and will be charged interest at the rate of 1% (or \$1.00, whichever is greater) each month on the balance thereof. It is the policy of Whitman County to take legal action against all customers who allow their accounts to remain in a past due status for longer than thirty (30) days. Should action be taken against you in the appropriate court, you will be notified of such by a court summons. If you have any inquiries as to the policies set forth above, please contact the main office located in the Public Service Building 2nd floor, Colfax, Washington, or telephone (509) 397-4622.

Agreement: I, as applicant hereto, agree to the following:

- (a) I authorize the Whitman County Department of Public Works to check any and all statements made in the application portion of this document. I additionally authorize all creditors (existing charge accounts) to release any information concerning my account or history thereof to the personnel of the Whitman County Department of Public Works so that the Whitman County Department of Public Works may do financial background on the status of my accounts. I understand that deliberately falsifying or providing false information on the application portion of this document will cause this application and any future applications for an account to be denied.
- (b) I further understand and agree to be responsible for and to pay to Whitman County any and all reasonable attorney's fees and court costs incurred by Whitman County should it be necessary under the terms of this agreement for the County to take legal action against me to collect the fees for dumping which have accumulated in any account established on my behalf pursuant to this application.
- (c) I additionally understand and agree to pay interest at the rate of 1% per month each month on the balance of any account established pursuant to this application for that portion of the account balance which represents dumping fees which I have not paid within 10 days of the billing date for such fees.
- (d) I further agree and understand that this agreement and application by me constitutes an offer to contract with and maintain an account with Whitman County, which, if accepted by Whitman County by granting me an account and allowing me to dump solid waste at the Whitman County Transfer Station, will constitute the formation of a binding contract. I acknowledge that it is the general policy of Whitman County not to allow dumping at its landfill except on a cash only basis and agree and understand that a deviation from the basic policy by allowing establishment of an account and dumping on a non-cash basis is valid and binding consideration given to me by the County.
- (e) I further understand and agree that should all, or any portion, of my account not be received by the 25th of the month following the date of the billing, I will thereafter not be allowed to dump solid waste at the Transfer Station. I will be required to pay cash at the time of such dumping and my account with the Whitman County Department of Public Works and Whitman County shall be terminated. I further understand and agree in the event that my account is terminated for any reason, such will not affect my obligation to Whitman County or Whitman County's rights to collect from me any attorney fees, court costs, all collection fees, the balance of the account or 1% rate of interest per month provided for in this agreement.
